

## **ST. STANISLAUS EX-STUDENTS ASSOCIATION**

### **Minutes of the Twenty-second Annual General Meeting of the Association held on Sunday 29<sup>th</sup> June 2008 in the School Museum**

Forty six members attended the meeting which commenced at 11.45 a.m.

The meeting was chaired by the President Fr. Jude Fernandes S.J., who after a short invocation, welcomed members.

In his address Fr. Jude mentioned the following points which we would like members to think over and take action.
